# Some Insights on the COVID-19 Vaccines

Now that COVID-19 vaccines are available, some residents want to learn more about the shots. MPC Ready member Sandy Bardas is happy to share her expertise on the subject. Bardas is a clinical pharmacist with a background in disaster preparedness and emergency response. She is part of a team that travels to long-term care facilities to vaccinate residents. She will provide an overview of the COVID-19 vaccines at the Feb 27<sup>th</sup> monthly MPC Ready community meeting. Here are a few key takeaways from her presentation.

What's in the vaccines made by Moderna and by Pfizer-BioNTech: Both vaccines contain messenger RNA, which teaches the body how to make a protein that triggers an immune response to the virus. The messenger RNA is enclosed in a lipid particle that contains a substance known as polyethylene glycol/polysorbate that is used in medications like PEG filgrastim and peginterferons.

**Possible allergic reactions to the vaccines:** Anyone with a known allergy to the injectable form of polyethylene glycol/polysorbate shouldn't be vaccinated. Also, anyone with a history of severe allergic reactions to vaccines should consult their allergist about whether to get vaccinated.

Whether the vaccines will be effective against emerging variants of the virus: Studies are ongoing to determine the effectiveness of the vaccines against the virus variants. The vaccines, as well as natural infection with the virus, produce a "polyclonal" response that targets several parts of the spike protein on the virus that allow it to pierce host cells and cause infection. The virus would likely need to acquire multiple mutations in the spike protein to evade immunity.

**Continuing to wear masks in public after being vaccinated:** The emerging variants seem to be highly efficient at spreading from person to person, so it's important for those who have been vaccinated to continue wearing a mask, maintaining physical distances from others and washing their hands.

**How long immunity will last after vaccination:** Experts don't yet know how long immunity lasts from either natural infection or the vaccines. It is possible that we may need booster injections for continued immunity.

If you want to learn more about the virus and the vaccines, Bardas recommends the trusted sources listed below and the websites of healthcare providers such as the Kaiser or Sutter Health. Be skeptical of information from social media and "Dr. Google" posts unless you can verify it with a trusted source, she adds.

## **Get Flood Ready**



Floods are a common natural disaster in the United States. Failing to evacuate flooded areas or entering flood waters can lead to injury or death. Everyone lives in an area with some flood risk. Check to see if you live in a FEMA designated flood zone at <u>https://msc.fema.gov/portal</u>. You can also visit floodsmart.gov to find out your National Flood Insurance Program options.

### What you should know about Flood Safety

- Make a family emergency communication plan and include pets.
- Have emergency supplies in place at home, at work, and in the car.
- Sign up for SMC Alert and also the Red Cross Flood App so you can receive emergency alerts delivered to your phone.
- Know what to do before, during, and after a flood. Learn more at ready.gov/floods.
- Flood insurance takes 30 days to take effect, so purchase now to protect your family!
- Listen to local officials by radio, TV or social media.
- Evacuate when advised by authorities or if you are in a flood or flash flood prone area.
- If you are on high ground above flooded areas, being prepared to stay where you are may be the best protection.
- Never drive or walk-through flooded streets; Turn Around, Don't Drown! Do not go through flood waters.
